

HEARING:

To Sue or Not to Sue

1 Corinthians 6:1-11 (pg. 1145)

Land Cor 6:1-6 If any of you has a dispute with another, do you dare to take it before the ungodly for judgment instead of before the Lord's people? ² Or do you not know that the Lord's people will judge the world? And if you are to judge the world, are you not competent to judge trivial cases? ³ Do you not know that we will judge angels? How much more the things of this life! ⁴ Therefore, if you have disputes about such matters, do you ask for a ruling from those whose way of life is scorned in the church? ⁵ I say this to shame you. Is it possible that there is nobody among you wise enough to judge a dispute between believers? ⁶ But instead, one brother takes another to court—and this in front of unbelievers!

⁷ The very fact that you have lawsuits among you means you have been completely defeated already. Why not rather be wronged? Why not rather be cheated? ⁸ Instead, you yourselves cheat and do wrong, and you do this to your brothers and sisters.

Paul's questions:

1. Don't you understand who you are?

2. Don't you see the damage this does to Jesus' reputation in the city?

Lack Cor 6:9-11 Or do you not know that wrongdoers will not inherit the kingdom of God? Do not be deceived: Neither the sexually immoral nor idolaters nor adulterers nor men who have sex with men[a] 10 nor thieves nor the greedy nor drunkards nor slanderers nor swindlers will inherit the kingdom of God. 11 And that is what some of you were. But you were washed, you were sanctified, you were justified in the name of the Lord Jesus Christ and by the Spirit of our God.

Community Group Questions

- 1. Have you ever heard of a ridiculous or frivolous lawsuit? What was it? Why is it so ridiculous?
- 2. Have you ever heard of or seen a situation where a Christian sued another Christian?
- 3. Read: Matt 5:38:40 How does this passage relate to lawsuits from Christians?
- 4. Re-read 1 Cor 6:9-11. Look at the list of sins that Paul gives. In our culture, every single one of these is common. But think about the words, "and that is what some of you were". How does this give us hope in our outreach and ministry? How does this encourage us keep working hard for Jesus?
- 5. What does it mean to be, "washed," "sanctified," and "justified" in the name of Jesus and by the Spirit of God?

REMEMBERING

Memorizing is one of the best ways of making truth stick. You can memorize something if you repeat it enough times. Try reading the verse 5 times a day until it sticks! Choose a part of it for your kids if needed.
